## 800 POINTS – PERSONAL STATEMENT

### Content

<p>300 Strong</p>	<ul style="list-style-type: none"> <li>• Academic experiences moderately exceed basic graduation requirements.</li> <li>• Professional experiences moderately exceed typical skill.</li> <li>• Demonstrates balanced participation in academic and/or professional activities, clubs, and organizations.</li> <li>• Held a leadership role in at least one activity.</li> <li>• Demonstrates commitment to rural practice.</li> <li>• Clear and relatively concise description of involvement.</li> </ul>

### Content

<p>300 Strong</p>	<ul style="list-style-type: none"> <li>Identifies the community to be served and the existing need for veterinary services with specificity.</li> <li>Provides detailed and organized information on how applicant will address the identified needs.</li> <li>Explains clearly and relatively concisely organizational structure.</li> <li>Demonstrates a thoughtful plan for establishing or joining a rural veterinary practice.</li> <li>Includes realistic projected costs and revenues, and growth.</li> </ul>
<p>200 Good</p>	<ul style="list-style-type: none"> <li>Identifies the community to be served and the existing need for veterinary services.</li> <li>Provides somewhat organized information on how applicant will address the identified needs.</li> <li>Explains the organizational structure of practice.</li> <li>Demonstrates a plan for establishing or joining a rural clinic.</li> <li>Includes projected costs, revenues, and growth.</li> </ul>
<p>100 So-so</p>	<ul style="list-style-type: none"> <li>Vaguely identifies community to be served and the existing need for veterinary services.</li> <li>Provides information on how to address identified needs.</li> <li>Demonstrates a general plan for establishing or joining a rural veterinary practice.</li> </ul>
<p>50 Poor</p>	<ul style="list-style-type: none"> <li>Difficulty in identifying community need.</li> <li>Provides little information on how applicant will address need.</li> <li>Fails to explain organizational structure or general practice plan for establishing or joining a rural veterinary clinic.</li> </ul>

## 250 POINTS – LETTER OF RECOMMENDATION

**\*\*Two Letters of Recommendation are required. Each Letter will be scored out of 250 points, for a total of 500 points.\*\***

250 Outstanding	<ul style="list-style-type: none"><li>• Demonstrates enthusiastic, in-depth knowledge of applicant.</li><li>• Observes excellence in commitment, performance, and interest in serving rural communities.</li><li>• Very highly recommends.</li></ul>
200 Strong	<ul style="list-style-type: none"><li>• Demonstrates in-depth knowledge of applicant.</li><li>• Observes strong commitment, performance, and interest in serving rural communities.</li><li>• Highly recommends applicant.</li></ul>
150 Good	<ul style="list-style-type: none"><li>• Demonstrates some knowledge of the applicant.</li><li>• Verifies applicant's experience and background.</li><li>• Recommends applicant for RVIP.</li></ul>
100 Weak	<ul style="list-style-type: none"><li>• Provides little information or unenthusiastic responses.</li><li>• Unable to verify applicant's experience and background.</li><li>• Provides a perfunctory recommendation only.</li></ul>
50 Not Supportive	<ul style="list-style-type: none"><li>• The recommendation does not support the applicant.</li></ul>



## 100 POINTS – FINANCIAL NEED

100	<ul style="list-style-type: none"><li>• Outstanding loan amount significantly exceeds at least half the cost of tuition and fees for at least one academic year.</li><li>• Demonstrated urgent need for loan assistance through RVIP.</li></ul>
50	<ul style="list-style-type: none"><li>• Outstanding loan amount exceeds at least half the cost of tuition and fees for at least one academic year.</li><li>• Demonstrated need for loan assistance through RVIP.</li></ul>
25	<ul style="list-style-type: none"><li>• Outstanding loan amount equals at least half the cost of tuition and fees for at least one academic year.</li><li>• No demonstrated need for loan assistance through RVIP.</li></ul>
